


3. THE CONTRACTOR IS REQUIRED TO NOTIFY AND COORDINATE ALL WORK WITH FWP PROJECT MANAGER.


- 4. SUBMITTALS ARE REQUIRED FOR ALL MATERIALS USED ON THE PROJECT

- 7. EQUIPMENT USED SHALL NOT LEAK FLUIDS. IT SHALL BE POWER WASHED BEFORE HAULING TO SITE AND EXAMINED BY PROJECT MANAGER
- 8. EQUIPMENT AND MATERIALS SHALL BE STAGED IN AREAS APPROVED BY THE PROJECT MANGER.

- 10. UNLESS OTHERWISE NOTED, CONTRACTOR SHOULD INSTALL FENCE IN PREVIOUS FENCE LOCATION.
- 11. FENCE SECTION A TO B INCLUDES REMOVAL OF SOME PORTIONS OF JACK LEG FENCE. A STANDARD FOUR WIRE BOUNDARY FENCE WILL BE INSTALLED IN THIS LOCATION. REMOVAL OF JACK LEG FENCE PORTIONS WILL BE PAID UNDER REMOVE FENCE AT UNIT BID PRICE.
























TOP LEFT: FENCE SECTION A TO B, AT POINT A


TOP RIGHT: FENCE SECTION A TO B, ALONG THE UPPER RIDGE


# TOP LEFT: FENCE SECTION C TO D, AT TOP OF HILLSIDE.



BOTTOM RIGHT: FENCE SECTION D TO E. LOOKING NORTH AT SECTION 22 GATE.




