# 2005 TRAPPING LEGISLATION

Bills introduced during the 2005 Legislative Session included HB 603 sponsored by Rep. Gail Gutsche (D-Missoula) which was intended to reform trapping laws. There were two sections to the bill, one that would make trapper education a mandatory state program and the second that would have directed the FWP Commission to consider implementing regulatory changes that included a required trap check, posting notice signs of trapping areas, owner notification of captured pet dogs, and implementing BMP's in trapping regulations. On February 17 the House Fish, Wildlife & Parks Committee tabled the bill on a tie vote.

Written testimony submitted by FWP at the committee hearing indicated support for the education component of HB 603. Although the bill did fail, this issue will likely surface in the 2007 legislature, so FWP is now seeking support and involvement from the state's trappers to move forward with the concept of a mandatory trapper education program. This could incorporate many aspects of the current voluntary MTA course and build off the success of FWP's mandatory Hunter and

Bowhunter Education. A required education program may preclude additional regulations.

## TRAP RELEASE BROCHURE

A brochure published last year through the furbearer program is still available at FWP offices. The "Recreationist Guide to Releasing Traps and Snares" and "Trapper Guidelines for Placement of Ground Sets" will familiarize outdoor recreationists with the mechanical operation and simple release techniques of various traps and snares. Although traps and snares are rarely encountered by bird hunters, skiers or hikers in Montana, it can occur and so this brochure is an excellent "how to" reference to release a dog quickly and safely from a trap. The brochure also includes a section for trappers regarding state regulations for the placement of body-gripping or conibear ground sets.

#### MONTANA YOUTH TRAPPER CAMP

The sixth annual Youth Trapper Camp is scheduled this summer for June 10, 11 & 12 at Beaver Creek Park south of Havre. Over 500 students have passed through camp classes and hands on activities since the first session in 2000. The FWP Commission met in Helena June 9 to adopt tentative furbearer quotas for the 2005 furbearer season. Public comment on the tentative quotas for bobcat, otter, fisher and wolverine will be accepted until mid-July. Final quotas will be adopted at the August 4 FWP Commission meeting in Helena.

### THINK ABOUT TRAP PLACEMENT

Next trapping season think about where you place your traps and snares. Trapping regulations are rather specific to 30- foot setbacks along roads and trails for some conibear sets and 1,000 feet from occupied dwellings and campgrounds for any ground set. However, to further reduce conflicts with hunting dog and pet dog owner's, placement of any type of set should be well off roads and trails that may be used by the public. By moving sets up to 100 feet away, you may not only avoid people with dogs, but also reduce trap disturbance or the loss of a captured animal. So...think trap placement!

# TRAPPING ON STATE LANDS

A resident conservation license allows hunters, anglers and trappers access to accessible state lands. However, licensed trappers are also required to obtain a Special Recreational Use License for Trapping (SRULT). For further information on how to apply for a SRULT contact a DNRC office. The application deadline is September 30th.
