Shipping permits are obtained either direct from this office, from Deputy Game Wardens or license dealers and are necessary when any resident or non-resident ships fish, game animals or parts thereof out of the State.

SAVE WILD LIFE BY PREVENTING FIRES—MAKE SURE YOUR FIRE IS COMPLETELY OUT AND LEAVE A CLEAN CAMP

Game Animals—Deer, elk, moose, antelope, caribou, mountain sheep, goat, and bear.

Fur-Bearing Animals—Marten or sable, otter, fox, muskrat, fisher, mink, raccoon and beaver.

Predatory Animals—Coyote, wolf, wolverine, mountain lion, wild cat, weasel, skunk and civet cat, black-footed ferret and bobcat.

Game Fish—Mountain trout, cutthroat or native trout, rainbow, grayling, steelhead trout, Dolly Varden trout, Loch Leven trout, Chinook Salmon, Silver Salmon, Sock-eye Salmon, Rocky Mountain whitefish, perch, ringed perch, large mouth black bass, small mouth black bass, Great Northern pike, wall-eyed pike, yellow pike, Mackinaw trout.

Upland Game Birds—Sharptailed grouse, blue grouse, prairie chicken, sage hen or sage grouse, fool hen, ruffed grouse, quail, Chinese pheasant and Mongolian pheasant, Hungarian partridge, ptarmigan and wild turkey.

Migratory Game Birds—Waterfowl, including wild ducks, wild geese, brant and swans; cranes, including little brown sandhill coots and whooping cranes, rails, including gallinules, sora or other rails, shore birds, including avocets, curlew, dowitcher, gotwits, knots, upland plover, killdeer, sandpipers, Wilson snipes or jacksnipes, snipes, stilts, plovers, willets, and yellowlegs; and mourning or turtle doves.

FISHING REGULATIONS

Effective May 20, 1945

To be in full force and effect through May 18, 1946, unless otherwise specified, subject to change, however, by the Commission prior to that date. For up-to-date information, inquire of your license dealer, sportsmen's club or Deputy Game Warden.

Regular Open Season: May 20, 1945 to November 15, 1945, both dates inclusive.

Regular Closed Season: November 16, 1945 to May 18, 1946, both dates inclusive.

The above regulations apply except where otherwise specified in the paragraphs below or under the county regulations following.

Hours of Fishing: Open from 6:00 o'clock a. m. to 10:30 o'clock p. m., Mountain War Time, in all waters unless otherwise specified.

Licenses not required for children under fifteen years of age.

All waters not mentioned in these Regulations are open to fishing for all species of fish during the regular open season.

The **Bag Limit** of game fish except sunfish and perch, shall be fifteen (15) fish or fifteen (15) pounds and one (1) fish, not more than five (5) of which shall be under seven inches in length, in any one day. It is hereby declared to be the intention of this regulation to provide that fifteen fish with a net weight of not more than fifteen pounds and one fish shall constitute the limit for a day's fishing. The daily limit on Crappie, Bream and Catfish shall be fifteen (15) pounds and one (1) fish. The limit on perch, sunfish and bullheads shall be fifty (50) fish per day. The possession limit for all fish shall be one day's legal catch unless otherwise specifically stated. This regulation shall apply to both fresh game fish and to game fish which have been dried, salted or otherwise cured.

Means of Taking: Only with hook, line or pole in hand, unless set-line fishing is specifically mentioned. Spears, seines, snares or traps unlawful to use or have in possession.

Sale or possession of salmon eggs or imitations shall be absolutely prohibited.

Set-lines shall not be permitted unless specifically stated otherwise.

Floats on set-lines prohibited.

It is prohibited to use ground or chipped meat, fish or other food products "to bait a hole" in any fishing waters. (This does not prohibit the use of meat or fish for bait.)

Fishing within three hundred (300) feet below all dams hereinafter listed under County regulations is prohibited.

Open Entire Year: It shall be lawful to catch any species of fish in the Yellowstone, Kootenai and Missouri Rivers throughout the entire year.

The following rivers shall be open to fishing for all species of fish during the entire year in open waters and through a hole in the ice: Milk River, Missoula River (or Clark's Fork of the Columbia River) from three hundred (800) feet below the Power Company Dam at Milltown to the Idaho line, Flathead River from Flathead Lake to its confluence with the Missoula River, the Clark's Fork of the Columbia River to the Idaho line, Clark's Fork of the Yellowstone River from its mouth to the Wyoming State Line, Little Horn River and the Big Horn River, and the Musselshell River from the Golden Valley-Musselshell County line to its confluence with the Missouri.

Set-line Fishing for Ling Only: (See Section 8694, Revised Codes of Montana.) The Yellowstone River from its mouth to the Bridge at Laurel on Highway No. 12; the Kootenai River; the entire Missouri River (except that portion in Lewis and Clark and Cascade Counties between the Morony Dam and the Holter Dam and that portion below the Fort Peck Dam beginning from the outlet of the tunnels to its confluence with the Milk River) shall be open to set-line fishing for ling only at all hours in open waters and through a hole in the ice during the entire year.

Winter Fishing: Winter fishing shall be permitted in such waters as are designated open under the regulations for individual counties.

Sockeye Fishing Regulations During Spawning Season: From October 1 to December 15, 1945, both dates inclusive, the limit on sockeye salmon shall be thirty-five (35) fish per day and not more than two-days' limit in possession in the following waters: Flathead Lake in Lake and Flathead Counties; Whitefish Lake in Flathead County, Lake Francis and that portion of the inlet canal as far as Conklin Gates in Pondera County and in the Clark's Fork of the Columbia River in Sanders County; however, in the above waters, from December 16, 1945, until September 30, 1946, the limit shall be fifteen (15) fish per day.

In the above waters only, snagging sockeye, with a combination of three hooks, shall be permitted from October 1st to December 15, 1945, both dates inclusive. During the balance of the open season, sockeye may be taken only by means of hook and line held in hand or hook and line attached to rod or pole held in hand.

BEAVERHEAD COUNTY

Closed Waters: The stream leading from the Decker Rearring Pond at Armstead to Horse Prairie Creek shall be closed to all fishing during the entire year.

Fishing within three hundred (800) feet below Divide Dam is prohibited.

Open Entire Year: The closed season shall be suspended entirely on Upper and Lower Red Rock Lakes.

Other Than Regular Season: Open water fishing shall be allowed for all fish in Red Rock Creek in its entirety, the Beaverhead River from the confluence of Red Rock Creek and Horse Prairie Creek to its confluence with the Jefferson River, and the Big Hole, from the bridge which spans the river at

Divide in Silver Bow County to its confluence with the Jefferson River, from May 20, 1945, to March 15, 1946, both dates inclusive.

All lakes shall be open to fishing from July 1, 1945, to November 15, 1945, both dates inclusive, with the exception of Elk and Brown's Lakes which are to be governed by the regular open season.

BIG HORN COUNTY

Open Entire Year: All Reservoirs and Stock Ponds in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

BLAINE COUNTY

Open Entire Year: Reservoirs No. 12 and No. 47 North of Zurich and the Reservoir located on the Miller Brothers' No. 7 Ranch, shall be open to fishing the entire year.

Winter Fishing shall be allowed through a hole in the ice on Reservoirs Nos. 4, 45 and 57 from December 1, 1945, to March 15, 1946, both dates inclusive.

CARBON COUNTY

Other Than Regular Season: The main Bluewater Creek shall be open to fishing from the point commonly known as the Fork of Frosty Jack Creek to its confluence with the Clark's Fork from October 15, 1945, to March 15, 1946, both dates inclusive, and closed from March 16, 1946 to October 14, 1946, both dates inclusive.

The first West Fork of Rock Creek shall be closed to all fishing permanently from the mouth of Washoe Creek (near Wild Bill Lake) to its confluence with the main stream of Rock Creek.

CARTER COUNTY

Open Entire Year: All Reservoirs and Stock Ponds in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

CASCADE COUNTY

Tintinger Sloughs of the Missouri River shall be closed to all fishing from May 10th to September 30, 1945, both dates inclusive, of each year and open at all other times.

CUSTER COUNTY

Open Entire Year: All Reservoirs and Stock Ponds in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

The Tongue River shall be open to fishing for the entire year from its confluence with the Yellowstone River to the Custer-Rosebud County Line.

Closed Waters: Lakes Garberson and Keough shall be closed to all fishing during the entire year.

DANIELS COUNTY

Open Entire Year: All Reservoirs and Stock Ponds in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

The Poplar River and Wolf Creek shall be open to fishing for all species of fish throughout the entire year in open waters, or through a hole in the ice.

DAWSON COUNTY

Open Entire Year: All waters in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

Set-line fishing for all species of fish through a hole in the ice only shall be permitted on the Yellowstone River in Dawson County at Intake, Montana, between the dam and the ferry landing.

DEER LODGE COUNTY

Closed Waters: That portion of Georgetown Lake within a radius of three hundred (300) feet from the mouth of Flint Creek shall be closed to fishing during the entire year.

Big Spring in Georgetown Lake, in an area designated by piles of buoys, for a distance of two hundred (200) feet north and south on the shore line out into the Lake, shall be closed to fishing during the entire year.

Flint Creek where it empties into Georgetown Lake, shall be closed from its mouth at Georgetown Lake to the Bridge on the Echo Lake road and the remainder open during the regular season from said Bridge to three hundred (300) feet below its source in Echo Lake.

That part of Stewart Mill Creek, above where the fence crosses it on Bowman's pasture, shall be closed to all fishing during the entire year.

California Creek, from the upper Forks to the headwaters, and American Creek, from the dam to its source, shall be closed to fishing during the entire year.

Hartdale Creek, between Georgetown and Silver Lakes, shall be closed the entire year.

Other Than Regular Season: All lakes except Georgetown, Silver, Storm and Echo Lakes shall be open to fishing July 1st, to November 15, 1945, both dates inclusive and closed the rest of the year.

Winter Fishing: Fishing in open waters and through a hole in the ice shall be allowed for all species of fish in Silver and Storm Lakes from December 1, 1945, to March 15, 1946, both dates inclusive.

Fishing in open waters and through a hole in the ice for all species of fish shall be allowed in Georgetown Lake between the hours of 6:00 o'clock a. m. to 10:30 o'clock p. m., Mountain War Time, on Saturdays, Sundays and legal holidays from December 1, 1945, to March 15, 1946, both dates inclusive; provided, however, that in case the said ice fishing is depleting the Lake too rapidly, the State Fish and Game Commission shall have authority to close the same upon five days' notice, the same to be published in a newspaper within Deer Lodge County.

The Creel limit in Georgetown Lake shall be ten (10) fish in the aggregate in any one day and the possession limit shall

be ten (10) fish at any one time, or fifteen (15) pounds and one (1) fish.

FALLON COUNTY

Open Entire Year: All Reservoirs and Stock Ponds in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

FERGUS COUNTY

Open Entire Year: All Reservoirs and Stock Ponds in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

Judith River, from the mouth of Big Spring Creek to the mouth of the Judith River, shall be open to fishing during the entire year in open waters and through a hole in the ice.

Other Than Regular Season: Crystal Lake shall be open to fishing from July 1, 1945, to March 15, 1946, both dates inclusive, in open waters and through a hole in the ice.

Spring Creek and Warm Spring Creek shall be open to fishing from April 1st to November 15, 1945, both dates inclusive.

FLATHEAD COUNTY

It shall be unlawful to use as bait or have in possession minnows, dead or alive, in Flathead County and Flathead Lake in its entirety.

Night fishing from 6:00 o'clock p. m. to 8:00 o'clock a. m., Mountain War Time, shall be prohibited in Flathead Lake between the dates of October 1st and December 15, 1945, both dates inclusive.

Closed Waters: Logan Creek from the inlet of Tally Lake to the Fourth Bridge, shall be closed to all fishing during the entire year in addition to five hundred (500) feet into the lake from the mouth of the stream which shall also be closed.

Fishing shall be prohibited between the highway bridge and the hydro-electric plant located on the Swan River, tributary to Flathead Lake.

Smith Lake shall be closed to all fishing during the entire year.

Middle Ashley Lake and the stream between Middle and Big Ashley Lakes shall be closed to all fishing.

Mud Lake Rearing Pond in the North Fork of the Flathead shall be closed to all fishing.

Herrig Creek, in Flathead County, a tributary of Bitterroot Lake, and Bitterroot Lake, within an area of three hundred (300) feet in all directions from where Herrig Creek enters Bitterroot Lake, shall be closed to all fishing.

Rand Creek, Wade Creek, Fish Creek and Cottonwood Creek, tributaries of Ashley Lake, shall be closed to all fishing. Ashley Lake, within an area of three hundred (300) feet in all directions from where these tributaries enter Ashley Lake, and Hatchery, or Rand Bay, shall be closed to all fishing.

Big Ashley Lake for a distance of three hundred (300) feet in all directions from the outlet shall be closed.

Fishing within three hundred (300) feet below the Northwest Dam on the Stillwater River is prohibited.

Open Entire Year: The closed season shall be suspended entirely on Flathead Lake, and fishing therein allowed during the entire year in open waters and through a hole in the ice, except that portion one thousand (1,000) feet into the lake, from the mouth of the Flathead and Swan Rivers, same marked by buoys, shall be closed from March 16, 1946 to May 18, 1946, both dates inclusive, and that portion in front of Somers Hatchery property lines to three hundred (300) feet out in lake, shall be closed to all fishing during State spawn taking operations in the fall. Also the following described area on the east shore—from Williamson's dock, which borders Dr. Richards' property on the North along the lakeshore to the Frowen property on the South, this includes all of Dr. Richards' property, the Thomlinson place, and the Thietz property and the Rahte and Frowen property.

McWinger Slough, Emmert Slough, Egan Slough, Lake Five and Lake Blaine shall be open to fishing for all species of fish in open waters and through a hole in the ice during the entire year.

The closed season shall be suspended entirely on Whitefish Lake and fishing therein allowed during the entire year in open waters and through a hole in the ice except that portion of the lake within a radius of two hundred (200) feet of the mouth of Swift Creek at the upper end of the Lake which shall be closed from November 16, 1945 to June 30, 1946, both dates inclusive.

Other Than Regular Season: Samson, Spencer, Beaver, Dollar, Murray, Chinook, Doyle and Hanson Lakes shall be open to fishing for all species of fish from October 1, 1945 to June 30, 1946, both dates inclusive, and ice fishing through a hole in the ice for all species of fish shall be permitted from October 1, 1945, to June 30, 1946, and closed during the remainder of the year.

Swift Creek, in its entirety, shall be open to fishing from July 1, 1945, to November 15, 1945, both dates inclusive.

That section of Flathead River, known as Foy's Bend, which lies between the old Stillwater Channel below Demersville Landing, to the mouth of Ashley Creek, shall be closed to fishing from July 1st to September 30th, both dates inclusive of each year, in addition to the regular closed season.

Rogers Lake shall be closed to fishing from November 16, 1945 to August 31, 1946, both dates inclusive.

Big Ashley Lake shall be closed to fishing from November 16, 1945, to June 15, 1946, both dates inclusive. The Creel limit in Big Ashley Lake shall be five (5) fish or an aggregate of ten (10) pounds and one (1) fish.

The entire Flathead River, from its mouth at the head of Flathead Lake to its confluence with the North Fork, shall be open to fishing in open waters and through a hole in the ice from November 16, 1945, to December 31, 1945, both

dates inclusive, and closed thereafter until the opening of the regular season May 19, 1946.

Skyles Lake shall be open only from December 1, 1945, to March 15, 1946, both dates inclusive, to fishing in open waters or through a hole in the ice.

Winter Fishing: Echo Lake shall be open to fishing for all species of fish only during the regular open season, and in open waters and through a hole in the ice from December 1, 1945, to March 15, 1946, both dates inclusive.

Big Martin Lake, Little Martin Lake, Upper Stillwater Lake and Meadow Lake shall be open to fishing through a hole in the ice only for all species of fish from December 1, 1945 to March 15, 1946, both dates inclusive.

Bass Fishing: Half Moon Lake and Peterson Lake and Blanchard Lake shall be open to Bass fishing during the regular open season. All other Bass waters in Flathead County, except those declared open the entire year, shall be closed to Bass fishing from May 10th, to June 30th, both dates inclusive of each year.

GALLATIN COUNTY

It shall be unlawful to use as bait or have in possession minnows, dead or alive, in the Madison River from Meadow Lake dam to the Yellowstone Park, including Meadow and Hebgen Lakes in Gallatin and Madison Counties.

Closed Waters: The Madison River and tributary streams from Hebgen Dam to Cabin Creek shall be closed permanently to all fishing.

That portion of Bozeman Creek (also known as Sour Dough Creek) from the Settling Basin of the water supply for the city of Bozeman to its source, including all tributaries and Mystic Lake, shall be closed to all fishing. That portion of Bozeman Creek (also known as Sour Dough Creek) from Story Street crossing to Keggy Lane shall be closed to all fishing.

Other Than Regular Season: Madison River, Duck Creek and the South Fork of the Madison above Hebgen Dam in Montana shall be closed to all fishing from October 1, 1945, to June 30, 1946, both dates inclusive.

Hebgen Lake and tributary streams above Hebgen Dam in Montana (except Madison River, Duck Creek and the South Fork) shall be closed to all fishing from October 1, 1945, to May 29, 1946, both dates inclusive.

Golden Trout Lake and Hidden Lake shall be closed from September 1, 1945, to July 31, 1946, both dates inclusive.

The creel limit in Golden Trout and Hidden Lakes shall be five (5) fish per day or an aggregate of ten (10) pounds and one (1) fish.

All other lakes in Gallatin County (except Hebgen Lake) shall be closed to all fishing from November 16, 1945, to June 30, 1946, both dates inclusive.

Portal, Cascade and Buffalo Horn Creeks and all tributary streams shall be closed to all fishing from November 16, 1945, to June 30, 1946, both dates inclusive.

All waters of the West Gallatin River and tributaries from County Bridge No. 14 (Axtell Bridge), and all waters of the East Gallatin River and tributaries from County Bridge No. 47 (Todd Stevens Bridge) to the bridge that crosses the Gallatin River at Logan; the waters included within Townships 1 and 2 South, Ranges 3, 4 and 5 East, shall be closed to fishing from March 15, 1945, to May 18, 1945, both dates inclusive and shall be open to fishing from May 20, 1945, to September 15, 1945, both dates inclusive, and shall be closed to fishing from September 16, 1945, to November 30, 1945, both dates inclusive.

Winter Season: The waters included within Townships 1 and 2 South, Ranges 3, 4 and 5 East, shall be open to winter fishing in open waters and through a hole in the ice from December 1, 1945, to March 15, 1946.

The entire Jefferson River shall be open to fishing in open waters and through a hole in the ice from December 1, 1945, to March 15, 1946, both dates inclusive.

Whitefishing: The main Gallatin River from its confluence with the Missouri to the bridge that crosses the Gallatin River at Logan and the main West Fork of the Gallatin River from the Axtell Bridge to the Williams Bridge shall be open to fishing in open waters and through a hole in the ice for whitefish only from December 1, 1945, to March 15, 1946, both dates inclusive.

GARFIELD COUNTY

Open Entire Year: All waters in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

GLACIER COUNTY

Open Entire Year: The Marias River shall be open to fishing in open waters during the entire year.

Winter Season: Mission Lake shall be open to fishing in open waters or through a hole in the ice from January 1, 1946, to February 28, 1946, both dates inclusive.

GOLDEN VALLEY COUNTY

The following regulations shall apply to Deadman's Basin Lake:

Open Season: June 10th, to November 15, 1945, both dates inclusive.

The creel limit shall be five (5) fish or ten (10) pounds and one (1) fish per day.

It shall be unlawful to use as bait or have in possession minnows, dead or alive.

Open Entire Year: All other reservoirs and stock ponds shall be open to fishing the entire year in open waters or through a hole in the ice.

GRANITE COUNTY

Closed Waters: Flint Creek which empties into Georgetown Lake, shall be closed from its mouth at Georgetown Lake

to the Bridge on the Echo Lake road and the remainder open during the regular season from said Bridge to three hundred (800) feet below its source in Echo Lake.

Ranch Creek, a tributary of Rock Creek, shall be closed in its entirety to all fishing during the entire year.

Little Fred Burr Lake and Big Fred Burr Lake are closed to fishing.

Winter Fishing: Fishing in open waters and through a hole in the ice for all species of fish shall be allowed in Georgetown Lake between the hours of 6:00 o'clock a. m. and 10:30 o'clock p. m., Mountain War Time, on Saturdays, Sundays and legal holidays from December 1, 1945, to March 15, 1946, both dates inclusive; provided, however, that in case the said ice fishing is depleting the lake too rapidly, the State Fish and Game Commission shall have authority to close the same upon five days' notice, the same to be published in a newspaper within Granite County.

The creel limit in Georgetown Lake shall be ten (10) fish in the aggregate in any one day and the possession limit shall be ten (10) fish at any one time, or fifteen (15) pounds and one (1) fish.

Race Track Lake shall be open to fishing through a hole in the ice only from December 1, 1945, to March 15, 1946, both dates inclusive.

HILL COUNTY

Other Than Regular Season: Fresno Lake shall be closed to all fishing from March 1, 1946, to May 18, 1946, both dates inclusive, and open throughout the rest of the year.

JEFFERSON COUNTY

Winter Fishing: The entire Jefferson River shall be open to fishing in open waters and through a hole in the ice from December 1, 1945, to March 15, 1946, both dates inclusive.

Boulder River from Cold Springs to its confluence with the Jefferson River shall be open to whitefishing from December 1, 1945, to March 15, 1946, both dates inclusive.

JUDITH BASIN COUNTY

Closed Waters: Russian Creek shall be closed from its source to its confluence with the South Fork of the Judith River.

Other Than Regular Season: Ackley Lake shall be open to fishing from June 15, 1945, to September 15, 1945, both dates inclusive, and closed the rest of the year. The creel limit shall be five (5) fish or ten (10) pounds and one (1) fish.

LAKE COUNTY

Night Fishing, 6:00 o'clock p. m. to 8:00 o'clock a. m., Mountain War Time, shall be prohibited in Flathead Lake in Lake and Flathead Counties from October 1st to December 15, 1945, both dates inclusive.

Open Entire Year: The closed season shall be suspended on Flathead Lake in Lake County during the entire year and fishing therein shall be allowed.

Closed Waters: Donaldson and Freeland Creeks, tributary streams of Lake Mary Ronan, shall be closed to fishing permanently; also three hundred (300) feet in all directions from where these creeks enter Lake Mary Ronan shall be closed permanently.

Other Than Regular Season: That portion of Nine Pipe Reservoir from the east boundary to permanent markers northwest of Highway No. 93, shall be closed to all fishing from April 15th to July 25, 1945, both dates inclusive, and same portion shall also be closed to fishing during duck hunting season, and during periods not mentioned, this portion shall be open to fishing. The balance of Nine Pipe Reservoir shall be open to fishing from July 1, 1945, to May 9, 1946, both dates inclusive, and closed from May 10th to June 30th, 1945, both dates inclusive.

Pablo Reservoir shall be closed to all fishing from April 15th, to July 25, 1945, both dates inclusive, and shall also be closed during duck hunting season and during the periods not mentioned, this reservoir shall be open to fishing.

Kicking Horse Reservoir shall be open to fishing for all species of fish from July 1, 1945, to May 9, 1946, both dates inclusive, and closed from May 10, 1946, to June 30, 1946, both dates inclusive.

Winter Fishing: Skaag Lake, Swan Lake, Nine Pipe, Pablo and Kicking Horse Reservoirs shall be open to fishing through a hole in the ice from December 1, 1945, to March 15, 1946, both dates inclusive.

LEWIS AND CLARK COUNTY

It shall be unlawful to use as bait or have in possession, minnows, dead or alive, in all waters tributary to the Gibson Reservoir in Lewis and Clark County.

Fishing within three hundred (300) feet below Gibson Dam and Diversion Dam is prohibited.

Other Than Regular Season: Sauerkraut, Willow Creek, Poorman, Humbug, Seven-up-Pete, Hogan, Black Diamond and Horse Fly, tributaries to the Big Blackfoot River in Lewis and Clark County, shall be closed from July 1, 1945, until May 18, 1946, both dates inclusive.

LIBERTY COUNTY

Open Entire Year: The Marias River shall be open to fishing in open waters during the entire year.

Closed Waters: Bear Gulch shall be closed to all fishing for the entire year.

LINCOLN COUNTY

It shall be unlawful to use as bait or have in possession minnows, dead or alive, in Lincoln County.

Open Entire Year: The following lakes shall be open to fishing for all species of fish in open waters and through a hole in the ice during the entire year: Leone, Crystal, Lavone, Horseshoe, Bootjack and Rainbow, near Happy's Inn; Dickey, Timber, O'Brien, Sophia, Moran, Carpenter, Rock and Frank

or Island Lakes in the Eureka District, also Bull, Savage, Lower Spar and Grouse Lakes in the Troy district.

The following waters shall be open to fishing for all species of fish in open waters during the entire year: Yaak River from the mouth to the falls; O'Brien Creek from the mouth to the city dam; Star Creek from the mouth to the falls; Lake Creek from the mouth to the Power Company Dam; Loon Lake and Dudley Slough in the Eureka district and the Kootenai River.

Closed Waters: The following waters shall be closed to fishing during the entire year: Slimmer Creek (to protect the Logan Park water supply), Flower Creek from the power dam to its source, excluding the lakes, O'Brien Creek from dam to its source and Alvord or Cowells Lake near Troy.

Other Than Regular Season: Kilbrennan Lake shall be closed to all fishing from September 16, 1945, to May 18, 1946, both dates inclusive.

Martin Lake shall be closed to all fishing from October 1, 1945, to May 18, 1946, both dates inclusive.

Howard Lake, Leigh, Upper and Lower Cedar Lakes, Upper and Lower Geiger Lakes, Sky Lakes or Owassa, Granite Lake, Hoskins Lake on the Yaak River, shall be open to fishing from July 1, 1945, to November 15, 1945, both dates inclusive, and closed from November 16, 1945, to June 30, 1946, both dates inclusive.

Winter Fishing: Schoolhouse Lake in the Troy District, The Thompson Lakes and Loon Lake near Happy's Inn and Loon Lake at the head of Pipe Creek and Tom Pool Lake on Pipe Creek, shall be open to fishing for all species of fish from December 1, 1945, to March 15, 1946, both dates inclusive, through a hole in the ice only.

MADISON COUNTY

It shall be unlawful to use as bait or have in possession minnows, dead or alive, in the Madison River from Meadow Lake Dam to the Yellowstone Park, including Meadow and Hebgen Lakes in Gallatin and Madison Counties.

Closed Waters: Harrison Lake (Willow Creek Dam) shall be closed to fishing the entire year. (This Lake reserved for State Spawning Station.)

Willow Creek inlet to Harrison Lake, or Willow Creek Dam, shall be closed to fishing the entire year from its confluence with the Lake to the weir approximately two hundred (200) feet above State Spawning traps.

That portion of Meadow Lake and Madison River from the Pontoon bridge at the head of Madison canyon to a point one mile below the Madison power plant shall be closed to fishing for the entire year.

The Ruby River and the irrigation canal from the Ruby River Dam to the Anderson Sheep bridge shall be closed to all fishing during the entire year.

North Meadow Creek, below the point where the electric transmission line of the Montana Power Company crosses said

creek, from the mouth of said streams shall be closed to all fishing during the entire year.

Other Than Regular Season: The Ruby River from Kelly's Bridge at Alder to its confluence with the Beaverhead River shall be open to fishing in open waters from December 1, 1945, to March 15, 1946, both dates inclusive.

All Lakes in Madison County except Meadow, Ruby Reservoir, Wade, Cliff and Hidden Lakes shall be open to fishing from July 1st to November 15, 1945, both dates inclusive.

The inlet to Wade Lake shall be closed to fishing for a distance of one hundred (100) feet in all directions from November 15, 1945 to June 30, 1946, both dates inclusive.

That portion of the Madison River and its tributaries from the Ennis-Jeffrys Bridge on Highway No. 1 to Cabin Creek shall be open to fishing from May 20, 1945, to October 14, 1945, both dates inclusive and closed to fishing from October 15, 1945 to November 30, 1945, both dates inclusive, and the Madison River only, not the tributaries, shall be reopened to fishing from December 1, 1945 to March 15, 1946, both dates inclusive.

The entire Jefferson River shall be open to fishing in open waters and through a hole in the ice from December 1, 1945, to March 15, 1946, both dates inclusive.

McCONE COUNTY

Open Entire Year: All waters in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

MEAGHER COUNTY

The use of minnows, dead or alive, as bait shall be prohibited in the following waters: Lake Edith, Boulder Lake, Camas Lake, Crater Lake, Cottonwood Lake, Lake Harris and Lake Martinsdale.

Closed Waters: Flagstaff Creek and tributaries to their headwaters, North Fork of the Musselshell from Lake Harris to the falls and the Supply Canal to Lake Martinsdale, in its entirety, shall be closed to fishing the entire year.

The creel limit in Lake Martinsdale and Harris shall be five (5) fish or ten (10) pounds and one(1) fish.

Other Than Regular Season: Holliday Dam on Flagstaff Creek shall be open to fishing from January 1, 1946, to March 15, 1946, both dates inclusive, and closed throughout the rest of the year.

Lake Sutherland shall be open to fishing in open waters or through a hole in the ice from December 1, 1945, to March 15, 1946, both dates inclusive.

The creel limit in the above waters shall be five (5) fish or ten (10) pounds and one (1) fish.

Camas Creek shall be open to fishing from May 20, 1945, to September 15, 1945, both dates inclusive.

Winter Fishing: The South Fork of Smith River from its headwaters to its confluence with the North Fork of the Smith

River shall be open to fishing in open waters and through a hole in the ice from December 1, 1945 to March 15, 1946.

MISSOULA COUNTY

Closed Waters: Rattlesnake Creek from the Montana Power Company Dam to its source in Missoula County shall be closed to all fishing during the entire year.

The following waters shall be closed to all fishing during the entire year: The West Fork of the Clearwater River and all its tributaries from its source to its mouth; Placid Creek and all its tributaries from its source to the bridge known as "the bridge to the Hunter Estate", approximately one mile from its mouth; East and West Twin Creeks from their source to their confluence with the Blackfoot River; O'Brien Creek and all its tributaries from its source to its mouth; Belmont Creek and tributaries, Beaver Creek; Blanchard Creek, Trail Creek, Cooney Creek, Humble Creek, Spring or Birch Creek and Glacier Creek from Stoner's homestead to Glacier Lake.

Other Than Regular Season: Johnson, Twin Bear and Finley Creeks shall be closed to all fishing from July 6, 1945, to and including May 18, 1946.

Winter Fishing: Harper's Lake shall be open to fishing in open waters and through a hole in the ice from December 1, 1945, to March 15, 1946, both dates inclusive.

The main Bitterroot River and the main Blackfoot River shall be open to whitefishing from December 1, 1945, to March 15, 1946, both dates inclusive.

Bass Fishing: Rainy Lake, Lake Alva, Lake Inez, Seeley Lake, and Salmon Lake shall be open to fishing for Black Bass from July 1st to May 10th, of the following year, both dates inclusive. For other species of fish these lakes shall be governed by the regular season.

The use of the Jack Lloyd or "cowbell" trolling lure or any device carrying more than two spinners or blades in tandem is prohibited at all times in Placid Lake.

MUSSELSHELL COUNTY

Open Entire Year: All Reservoirs and Stock Ponds, including Miller Lake, in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

PARK COUNTY

Closed Waters: Aldrich Lake shall be closed to all fishing during the entire year.

Winter Fishing: Dailey's Lake shall be open to fishing through a hole in the ice from December 1, 1945, to March 15, 1946, both dates inclusive.

PETROLEUM COUNTY

Open Entire Year: All Reservoirs and Stock Ponds in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

PHILLIPS COUNTY

Open Entire Year: All Reservoirs and Stock Ponds in the County shall be open to fishing the entire year in open waters or through a hole in the ice, except No. 95 P. R. Reservoir.

Closed Waters: No. 95 P. R. Reservoir shall be closed to all fishing during the entire year.

PONDERA COUNTY

Open Entire Year: The Marias River shall be open to fishing in open waters during the entire year.

Winter Fishing: Lake Francis near Valier in Pondera County shall be open to fishing in open waters and through a hole in the ice for all species of fish from December 1, 1945, to March 15, 1946, both dates inclusive.

POWDER RIVER COUNTY

Open Entire Year: All waters in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

POWELL COUNTY

Open Entire Year: The closed season shall be suspended entirely on Cottonwood Creek which flows through the town of Deer Lodge.

Closed Waters: Arastra Creek, from the Bill Steele Dude Ranch to its headwaters, shall be closed to fishing during the entire year.

The Little Blackfoot River from its headwaters to the lower boundary or line of the Little Blackfoot Meadows, and Three Mile and Hope Creeks, tributaries to the Little Blackfoot River, shall be closed to fishing during the entire year. The remainder of the Little Blackfoot River and all other tributaries shall be governed by the regular open and closed seasons.

All streams and tributaries running into Cooper's Lake shall be closed during the entire year.

Other Than Regular Season: All lakes in Powell County shall be closed to fishing from November 16, 1945, to June 30, 1946, both dates inclusive, with the following exceptions: Rock Creek Lake, Cooper's Lake, Miller's Lake and Nevada Creek Lake, which shall open with the regular season.

Nevada Creek Lake shall be open May 20, 1945, to August 31, 1945, both dates inclusive, and closed throughout the rest of the year.

Winter Fishing: Brown's, Jones', Cooper's and Opsata Lakes shall be open to fishing in open waters and through a hole in the ice from December 1, 1945, to March 15, 1946, both dates inclusive.

Fishing in open waters and through a hole in the ice shall be permitted in the Little Blackfoot River from its mouth to the Snowshoe crossing from December 1, 1945, to March 15, 1946, both dates inclusive.

Fishing through a hole in the ice shall be permitted in Rock Creek Lake on Sundays and legal holidays from 9:00 o'clock a. m. to 6:00 o'clock p. m., Mountain War Time, from December 1, 1945, to March 15, 1946, both dates inclusive.

The Big Blackfoot River shall be open to whitefishing in its entirety in Powell County from December 1, 1945, to March 15, 1946, both dates inclusive.

PRAIRIE COUNTY

Open Entire Year: All Reservoirs and Stock Ponds in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

RAVALLI COUNTY

Winter Fishing: The main Bitterroot River and the East and West Forks of the Bitterroot River shall be open to whitefishing from December 1, 1945, to March 15, 1946, both dates inclusive.

RICHLAND COUNTY

Open Entire Year: All Reservoirs and Stock Ponds, with the exception of Sugar Lake, in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

Closed Waters: Sugar Lake shall be closed to all fishing during the entire year.

ROOSEVELT COUNTY

Open Entire Year: All waters, except Frazer Lake, in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

Closed Waters: Frazer Lake shall be closed to fishing during the entire year.

ROSEBUD COUNTY

Open Entire Year: All Reservoirs and Stock Ponds in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

SANDEERS COUNTY

Winter Fishing: Rainbow (or Dog) Lake and Burgess Lake shall be open to fishing through a hole in the ice for all species of fish from December 1, 1945, to March 15, 1946, both dates inclusive.

SHERIDAN COUNTY

Open Entire Year: All waters in the County shall be open to fishing the entire year in open waters or through a hole in the ice.

SILVER BOW COUNTY

Fishing within three hundred (300) feet below Divide Dam is prohibited.

Closed Waters: That branch of the Big Hole River known as the Butte Angler's Club Rearing Ponds, from the break-water to where it flows into the main channel of the Big Hole River (a distance of about one mile), shall be closed to all fishing during the entire year.

Winter Fishing: Open water fishing shall be allowed for all species of fish in the Big Hole River from the bridge which spans the river at Divide in Silver Bow County, to its confluence with the Jefferson River from December 1, 1945, to March 15, 1946, both dates inclusive.

STILLWATER COUNTY

Closed Waters: West Rosebud River from the head of Emerald Lake to the Mystic Lake power plant shall be closed to all fishing during the entire year.

The West Fork of the Stillwater River from the Bridge (commonly known as the George Torian Bridge) to its headwaters including all tributaries thereto, shall be closed to fishing for the entire year.

SWEETGRASS COUNTY

It shall be unlawful to use as bait or have in possession minnows, dead or alive, in the Boulder River in its entirety in Sweet Grass County.

Closed Waters: The East Boulder River shall be closed to fishing from the fence at the Anderson Hot Springs' buildings to its source.

The Yellowstone Sloughs from the State Fish Hatchery grounds to its confluence with the Yellowstone River shall be closed to fishing.

The creeks on the Elmer Budd ranch and the Newpalmer ranch, tributaries to the Boulder River, shall be closed in their entirety to all fishing during the entire year.

Lost Lake in the Boulder Valley, together with the outlet from the Lake to its confluence with the main Boulder River shall be closed to all fishing during the entire year.

The East Fork and tributary streams in Sweet Grass and Park Counties shall be closed to all fishing until May 18, 1946.

The Upper Main Boulder River from Coles Bridge to its headwaters in Sweet Grass County shall be closed to all fishing during the entire year.

Open Entire Year: Glass Lindsay Lakes shall be open to fishing the entire year in open waters and through a hole in the ice.

TETON COUNTY

It shall be unlawful to use as bait or have in possession minnows, dead or alive, in all waters tributary to the Gibson Reservoir in Lewis and Clark and Teton Counties.

Closed Waters: Big George, Hanan, Blacktail and Wagner Creeks shall be closed to all fishing during the entire year.
