Welcome and Introductions: Sam Sheppard

Andrea Jones provided a brief legislative update regarding the passing of HB140. It is good news for the Department, but the bill was amended from the original. The senior age for license discount was not raised to 67 (remains 62). And an apprentice hunter certificate was included in the bill to allow individuals 10-17 to hunt without hunter education. Those individuals must still hunt with a mentor and can only use an apprentice certificate for two years. There is also a \$5 fee for that certificate. Other guidelines apply.

The Department is still approximately \$900,000 short of what it needed.

Harold Johns asked about Department acquisition of land and how that might be affected by recent legislative action and asked that the Department work harder to inform or educate on its land purchases/acquisitions.

Hunter Ethics Campaign

Dennis Nelson gave a thorough fundraising report for the Hunter Ethics Campaign (HEC). The HEC has received commitment from FWP headquarters for \$5,000 in seed money and is fairly confident that its application to Montana's Outdoor Legacy Foundation (MOLF) will result in matching funds. Also Jill McMurray has been in touch with Sitka, who could not offer cash, but instead offered some product. Discussion followed on how the product could be used to bring in cash (i.e. used in a raffle or as a reward).

David Gibson briefly discussed his presentation to the Safari Club about the HEC and felt positive about its willingness to potentially donate.

Dennis called upon the group to commit to talking to individuals with whom they are acquainted at stores, organization and in other agencies about supporting the HEC through cash.

Several CAC members offered to make contacts with groups, individuals.

Mike England asked that the CAC continue to update the charts in Google Docs with the funding contacts mentioned above. To use Google Docs, URL: https://docs.google.com/, Username: fwpregion3cachec@gmail.com, ask Mike or Andrea for password.

Mike then displayed the new options for the Hunt Right logo. And the group unanimously approved the logo and also approved the potential to set aside up to \$1,000 of its funding to use the graphic designer who made the logo and retain rights to it, etc.
