## **Montana Archery in the Schools Program (NASP) Equipment Assistance Application**

The National Archery in the Schools Program (NASP) is designed to promote international style target shooting during physical education classes 4-12. Montana Fish, Wildlife & Parks (FWP) believes that students involved in a target archery program will learn a lifelong skill, increase their self-esteem, and increase physical activity. In Montana, FWP is the sponsoring organization for NASP.

Thanks to the Easton Foundation, Schools who are first time NASP equipment purchasers can be eligible to receive a \$1,000 discount off the total cost of a classroom archery kit. Also, current NASP schools that need to replace equipment are eligible to receive up to a 25% discount for orders up to \$800. **To receive financial assistance from NASP you must first contact FWP and receive approval prior to ordering equipment from the national office.** Failing to do so will make your request ineligible. The deadline is December 31, 2020.

A standard NASP start up archery kit includes: 12 Genesis bows, 5 targets, 5 dozen arrows, and an arrow curtain. The approximate cost is \$3,000. For a school to be eligible to obtain a kit there must be at least one instructor who has successfully completed a NASP Basic Archery Instructor (BAI) certification workshop and match the donation by \$1,000 if first time school. Awards will be presented on a first come first served basis if the school meets the criteria for having an NASP in-school archery program.
