EXECUTIVE SUMMARY

This report summarizes weed management expenditures and accomplishments across all three divisions of Montana Fish, Wildlife and Parks (FWP) during Fiscal Year 2019, which includes July 1, 2018 through June 30, 2019.

FWP administers 491 distinct sites across the state and is responsible for noxious weed management on each of these areas. The acreages associated within each separate Division are as follows:

- The Fisheries Division manages approximately 16,651 acres in fee title and leased lands across 348 sites, primarily Fishing Access Sites (FAS's).
- The Wildlife Division manages approximately 450,224 acres in fee title and leased lands across 81 sites, primarily as Wildlife Management Area (WMA) lands.
- The Parks Division manages approximately 41,770 acres in fee title and leased lands across 57 sites, primarily as State Parks.

FWP continues to implement an integrated approach to controlling noxious weeds, as further described in FWP's statewide noxious weed plan (2008). That plan can be accessed and downloaded using the following web link: <http://fwp.mt.gov/fishAndwildlife/habitat/noxiousWeeds/default.html>

Using an integrated approach to managing weeds, FWP staff prioritize efforts and select the most appropriate technique for addressing each noxious weed issue. For instance, infestations with a high likelihood of spreading to new locations are a priority for herbicide treatment, including parking lots, roads, and other high public use areas. New infestations in areas that previously lacked infestations or new noxious weed species are also a high priority for treatment and eradication, if possible. Vast infestations often require a different approach in collaboration with neighboring properties and county weed coordinators. Biocontrol in combination with herbicide applications at strategic locations are commonly used as a long-term solution where infestations are extensive, spanning multiple ownerships.

FWP also strives to take an ecological approach to weed management and prevention. This includes, where possible, avoiding ground disturbance, minimizing impacts from construction or other management activities, and being mindful to avoid impacting non-target vegetation when implementing weed control measures.

During FY2019 FWP treated over 5,994 acres with herbicides, an increase of approximately 376 acres from the previous fiscal year equaling about 12% of reported estimated infested acres (Table 2) for the year. Combined with other types of treatments – mechanical and insect/biocontrol, the department treated approximately 8,638 acres and grazed 6,194 acres with expenditures being an estimated total of \$347,910 on weed management (Table 3). Some personnel costs, training, education and outreach, and other aspects of weed management and prevention are not included in these figures.

In addition to work on FWP lands, the department also provides funding toward weed management on private lands through the Block Management Program (Table 1). In 2019, FWP paid over \$ 287,739 to private landowners specifically to weed control.

FWP works closely with other government agencies including Department of Natural Resources and Conservation, U.S. Forest Service, Department of Agriculture, and County Weed Coordinators along with private contractors and private landowners, to coordinate weed control efforts and to help contain the spread of noxious weeds throughout the state.

FWP also strives to utilize other collaborative efforts for weed control with public service programs such as AmeriCorps and the Montana Conservation Corps. Through these efforts, Montana State Parks AmeriCorps (MSPA) members were responsible for 426 hours of service pertaining to weeds on FWP-managed properties. Duties within those hours included noxious weed management tasks such as recruiting volunteers for and conducting hand pulling weeds, biological control releases, and herbicide treatments which resulted in 59.4 acres of weeds treated in addition to conducting vegetation monitoring of known infested sites.

MSPA also conducted an impact evaluation examining its members efficacy in treating noxious weeds. This evaluation examined 6 sites (approximately 12 acres) known to be infested with spotted knapweed and utilized a Before/After-Control/Impact design. It found a 6% reduction of spotted knapweed cover, 25% reduction of total noxious weed cover, and a 13% increase in beneficial plant cover as a result of member’s treatments after one season.

Fiscal Year 2019 saw the second round of applications for the Wildlife Habitat Improvement Program (WHIP) administered by FWP. WHIP was passed into law with the purpose of restoring ecologically important wildlife habitats by managing noxious weeds at watershed or landscape scales, typically involving collaborative efforts over multiple landownerships. The Act makes available up to \$2M annually in federal Pittman-Robertson Wildlife Restoration (P-R) funds. In FY19 the WHIP Advisory Council voted to fund four submitted grants totaling \$1,161,987. These projects started receiving WHIP funding on August 1st, 2019:

- **Centennial Valley Project – 5 Year project**
 - o 43,368 acres of priority wildlife habitat, 1,050 acres receiving herbicide treatments and reseeded, with a request of \$63,180
- **Tenderfoot/Bald Hills Project – 5 Year Project**
 - o 10,000 acres of priority wildlife habitat, 4,435 acres receiving herbicide treatment and improved grazing structures, with a request of \$40,000

- **Upper Stillwater Watershed Project – 5 Year Project**
 - o 220,000 acres of priority wildlife habitat, 3,774 acres receiving herbicide treatment, with a request of \$275,435
- **Fish and Nemote Creeks Project – 5 Year Project**
 - o 127,775 acres of priority wildlife habitat, 27,844 acres receiving herbicide treatments, biological control agents and reseeding, with a request of \$783,372

The Data Tables Section of this report, which follows, summarizes weed infestation and control activities over most of the sites managed by FWP. This data is collected annually from the staff responsible for managing these sites. Data are organized by Administrative Region (Figure 1) and then by Division and County.
