Hello FWP! First of all, I want to express my support for and appreciation of FWP's wildlife conservation efforts throughout the state.

I am an avid outdoor recreator based in Missoula; I enjoy backpacking, wildlife photography, and hunting. I cherish the presence of Grizzly Bears in our state, and I hope they are always here.

However, I strongly believe that it is time for the bears to be actively managed with limited permit hunting. By no means do I desire to see the population reduced significantly, and I myself have no desire to hunt them; rather, I believe tags given out to hunt Grizzlies would establish a new relationship between humans and the bears that will affect their behavior in a way that favors less human/wildlife conflict.

To rephrase: I am often concerned about my own safety when hunting, camping, and hiking in dense Grizzly Bear habitat, and the bears' lack of aversion to humans is a strong aspect of this fear.

As is the case with Black Bears, Wolves, and Mountain Lions, I believe that even a limited amount of hunting pressure on Grizzly Bears will tend to push them into wilder country (where they belong, away from roads and developments), and make them more apt to flee when hearing/smelling/seeing humans.

Please embrace the objective science in this situation: the population has recovered. Full Stop. They are no longer endangered. They need to be managed as our other large mammals are managed (ie with properly regulated hunting).

This is fact, not opinion. Misplaced anthropomorphized emotion has no place in wildlife management.
