1. Summary of significant results.

Continued to quality check fish cross-reference table with EPA river reach number. Worked with Jim Senkler (NRIS programmer) and made report from new and updated EPA file received from Duane Anderson, NWPPC data manager. Began quality checking corrections to EPA system with reports. Cross checked and re-edited new master EPA file. Made list of new changes to master EPA file. Began adding new reaches which contain recommendations and fish data to master EPA file.

Prepared for and attended Data Needs Assessment Task Force meeting in Helena facilitated by John Mundinger and attended by representatives from regions and each division. Outlined tasks needed to be completed and set schedule for completing tasks. Will be in charge of fisheries division data needs assessment.

Received questions/comments from Jim Senkler concerning interagency fisheries data base structures. Sent memo to fish division data committee to review interagency data structures and inventory other existing data bases.

Drafted response to BPA's NED long-term management plan. Sent to Chris Hunter for review and final mailing.

Wildlife: Presented poster on MRIS for the Montana Riparian Association and attended part of workshop. Attended first Department GIS subcommittee meeting in Helena. Worked on structuring wildlife division "needs assessment" procedures for data management and GIS. Drafted evaluation form to be sent to previous MRIS users.

Recreation: Outlined new structure from original recreation data base, reclassified "extras and reasons." Began re-designing new criteria list and inventory worksheet for recreation managers. Reviewed and decoded hard copy of original recreation database (779 reaches); noted

discrepancies in data; catorigized data with respect to new data structure. Initiated state library data search on recreational usage of Montana's rivers. Completed letter of introduction and questionnaire to all USFS, BLM, and DFWP recreation managers.

NRIS: Assisted MRIS demonstration at Riparian Conference - Big Mountain, September 5, 6, 7, 1990. Demonstrated MRIS to Charles Chesny, contractor for the Kootenai National Forest, September 17, 1990. Demonstrated MRIS to state agency librarians, September 15, 1990. Contacted DHES and EPA personnel to find out how EPA RRN's and update is being coordinated. Waiting to hear from Phil Taylor of EPA's Washington, D.C. office. Arranged for NHP intern to do data entry for NAT/GEO RRN watercode cross. Work to commence October 10, 1990. Restructuring stream and lake data.

Incorporate managers comments into needs assessment document to be completed by December, for Department.

Wildlife: Complete and mail MRIS evaluation form to users. Continue interagency coordination of MRIS wildlife update. If final EPA reach description file is available, work on cross-reference of old data to new system. Work with wildlife division members of GIS subcommittee on design and implementation of needs assessment. Attend game managers meeting in Lewistown to discuss "needs assessment" process.

Recreation: Will meet with Stephen McCool at University of Montana. Will meet with Jim Senkler, MRIS programmer, to revamp recreation database structure.

NRIS: Write report summarizing follow-up calls. Contact Tom Foor and Dave Hyndman, U of M. Supervise NHP intern on GEO/NAT data entry. Continue restructuring of stream and lake data. Download NRIS data requests and assist in creating the survey mailing list.
